

**Presbytery of Plains and Peaks – CALLED Meeting  
October 29, 2020  
First United Presbyterian Church – Loveland, Colorado AND Virtually**

The Presbytery of Plains and Peaks met on Thursday, October 29, 2020 in person and virtually. This meeting has been called with the concurrence of two teaching elders, not serving the same congregation, and two ruling elders from different churches. #### Ratifying Motions

Presbytery VOTED to ratify the actions taken at the August 6 and October 24, 2020 stated Presbytery meetings. The motion covers the entirety of the actions taken.

Background information: Prior to the October 24, 2020 stated meeting, the *Standing Rules* stated that “churches throughout the Presbytery will be invited to host meetings.” There was no provision for conducting the business of the stated meetings over electronic media platforms.
