Permanent Judicial Commission

Membership: Seven (7) members, ministers and ruling elders in numbers as nearly equal as possible, elected to terms of six (6) years, in three (3) classes as nearly equal as possible and with no more than one half (1/2) of the members to be in one (1) class. Not more than one (1) ruling elder member may be from any one (1) church.

Members are not eligible for reelection until after four (4) years have elapsed.
